

Re ALJ statement: "*respondent submits 3 photos of an **unidentified vehicle** parked some distance from a bus shelter in an unidentified location.*"

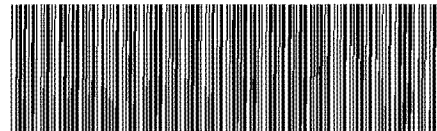

If necessary my friend is willing to come to court with me and will testify under oath (as will I) to the validity of these statements. If a court appearance is necessary I am requesting the officer who issued the ticket be present as well. As you can see my car **is not** parked illegally. Also, photo number 4 is an enlargement of photo number 2 (and can be enlarged further upon request) to clearly show my license plate in that location. I am not guilty of parking illegally in any way.


